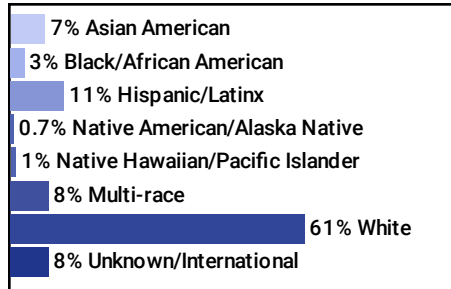

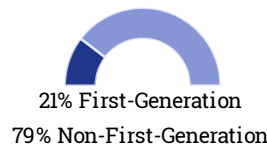

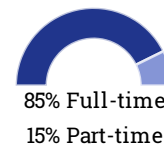

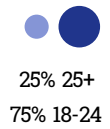
First-Generation Status

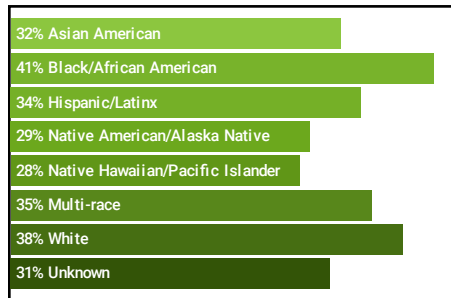

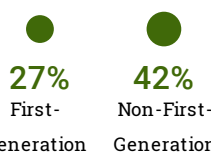

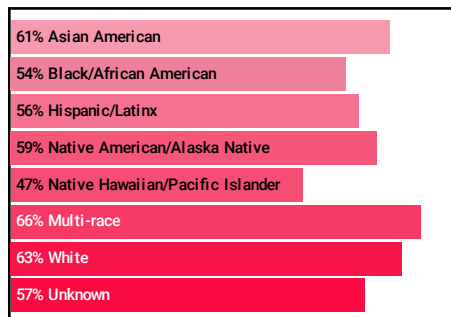
Pell Grant 4-Year Grad Rate

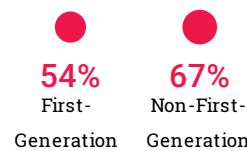
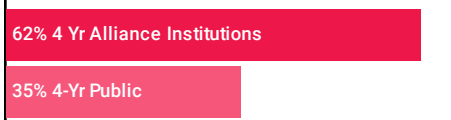

4-YEAR Graduation Rates

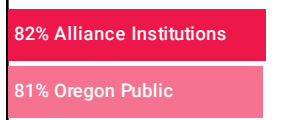


Compare Public to Private Grad Rates

Data are from academic year 2016-17 except where noted

ENROLLMENT	
Total Students	Includes Oregon-resident and non-resident; full-time and part-time; as well as graduate, undergraduate, and non-degree-seeking students.
Race/Ethnicity	Includes undergraduate students enrolled (both degree- and non-degree-seeking). Race/Ethnicity is self-reported. "International" is more traditionally defined as "non-resident alien" in institutional reporting. The non-resident alien population comprises 4% of total and was excluded from the calculation of students of color.
First-Generation Status	First-generation is independently defined by each member institution. Most Alliance schools follow the definition of a first-generation student is a student who reported that no parents completed education (i.e. received a postsecondary certificate or degree) beyond high school or its equivalent. If one parent in a two-parent household has completed a certificate, associate degree, or bachelor's degree, that student is not considered a first-generation college student. This matches the FAFSA definition. The data includes all first-generation students, regardless of whether they filed a FAFSA/ORSAA (Oregon Student Aid Application). **Northwest Christian University and Pacific Northwest College of Art first-generation information is unavailable.
Enrollment	Distinction is independently defined by each member institution.
Students from Oregon	Category is independently defined by each member institution. Members reported 14,761 total students from Oregon.
Prior Oregon Community College Experience	Includes those students that entered university with Oregon community college credits on submitted transcripts. **Multnomah University, Northwest Christian University, and Oregon College of Art and Craft data are unavailable.
Age Bachelor's Degree Earned	Includes those students who graduated with a bachelor's degree between 7/1/2016 and 6/30/2017.
Enrolled	Includes Oregon-resident and non-resident, full-time and part-time, and degree- and non-degree-seeking students.
Degrees Conferred	Chart describes the number of unduplicated students awarded degrees between 7/1/2016 and 6/30/2017. 1% of students received a post-baccalaureate or post-master's certificate.
Gender	Includes all students, both degree- and non-degree-seeking students. Gender is self-reported and students may choose to not report or select "other."
AFFORDABILITY	
Affordability Data	Refers to ALL degree-seeking undergraduate students, regardless of whether they filed a FAFSA/ORSAA except where noted. Non-resident aliens are excluded from all public grant (Pell and OR Opportunity) calculations. **Concordia University and Northwest Christian University financial aid data are unavailable, excepting Cost of Attendance numbers.
Students Able to Meet Expenses with Expected Resources	Students for whom the total cost of attendance does not exceed the sum of their federally expected family contribution (EFC), public and institutional aid package, and own earnings. The estimate of students' earnings follows the Oregon Opportunity Grant formula of 90% of minimum wage times 15 hours per week times 48 weeks.
Race/Ethnicity	Describes percentage of students able to meet expenses with expected resources. Race/Ethnicity is self-reported.
First-Generation	Describes the percentage of first-generation students (and parallel share of non-first-generation students) who are able to meet expenses with expected resources. For definition of first-generation status, see Enrollment section above.
Undergraduates with Financial Need	Category defines degree-seeking students that filed a FAFSA/ORSAA and were determined to have financial need.
Pell and OR Opportunity Grant Data	"Federal Pell" percentage describes the percentage of total undergraduate degree-seeking students that received a Pell Grant. "OR Opportunity" percentage describes the percentage of total Oregon state money that was awarded to Alliance undergraduates in 2015-16. Source is the Oregon Office of Student Access and Completion.
Average OR Opportunity Grant Award	Reflects weighted average award for Alliance undergraduate in 2015-16. Maximum award is \$2,250. Source is Oregon Office of Student Access and Completion.
Pell Grant 4-Year Grad Rate	Data measure the four-year graduation rates for those students that received Pell Grants from the adjusted Fall 2009-10 cohort (includes first- and non-first-time and full- and part-time students). A graduation is the awarding of a bachelor's degree. These percentages reflect those students that earned bachelor's degrees before 8/31/2013.
Alumni Loan Default Rate	Cohort default rate is based on a three-year period. The students in the 2014 cohort entered federal student loan repayment within the 2014 fiscal year, and the default rate describes those students who defaulted on loan within the subsequent three years. Reflects data as of September 2017 and defined by the Office of Student Financial Assistance Programs (OSFAP).
Average Cost of Attendance (COA)	Data include all undergraduate students <i>who were awarded financial aid</i> . Cost of attendance is based on institutional reports of standard student budgets including tuition/fees, books/supplies, room/board, personal expenses, and transportation. Public aid includes Pell Grant and OR Opportunity Grant. Data represent non-weighted averages.
Average Cost of Attendance (COA) Components	Components are independently defined and published by each institution.

4-Year Graduation Rates	Revised Fall 2011 cohort total includes only first-time, full-time, and degree-seeking first-year students. A graduation is the awarding of a bachelor's degree. These percentages reflect those students that earned bachelor's degrees before 6/30/2015.
Race/Ethnicity	Describes percentage of students in revised Fall 2011 cohort (noted above) who earned bachelor's degrees before 06/30/2015. Race/Ethnicity is self-reported.
First-Generation	Describes the percentage of first-generation students (and parallel share of non-first-generation students) from the revised Fall 2011 cohort who earned bachelor's degrees before 6/30/2015. For definition of first-generation status, see Enrollment section above. **In addition to those identified in "First-Generation Status" in Enrollment section, Corban University and Multnomah University first-generation outcome data are unavailable.
1st-Year Retention Rates	Reflects the percentage of first-time, full-time undergraduates from revised Fall 2016 cohort who were still enrolled at the university in Fall 2017.
Public to Private Graduation Rates	Common Data Set Oregon Public Universities 4-year graduation numbers for the adjusted Fall 2011 cohort.
Median Annual Earnings and Likelihood of Prosperity	Source is the "Mobility Report Cards: The Role of Colleges in Intergenerational Mobility," by Raj Chetty, John Friedman, Emmanuel Saez, Nicholas Turner, and Danny Yagan. The project sponsored by The Equality of Opportunity Project (EOP). These statistics represent only those Alliance schools included in the study. The median numbers provided are based on estimates from millions of anonymous tax filings and tuition records. Measures of access are for students born in 1991, roughly the class of 2013; measures of outcomes and mobility are for students born between 1980 and 1982, who are around age 35, when relative income ranks stabilizes.
